## **P.O.W.W.E.R. Ministries Inc. Ministry Participation Criteria**

---

ALL NEW MINISTRY LEADERS, REGARDLESS OF PREVIOUS MINISTRY ORDINATION  
MUST COMPLETE THE PMI BIBLE COLLEGE WHILE IN POSITION AT P.O.W.W.E.R. MINISTRIES INC. IN ORDER TO MAINTAIN  
POSITION!!!!

- ❖ You must be or willing to become a 100% tithing member of P.O.W.W.E.R. Ministries Inc. for a period of no less than 5 years and remain in good standing.
- ❖ You must have the Holy Ghost with the evidence of speaking with other tongues.
- ❖ You must be a person of honest report (blameless) within the body of Christ. You must have unshakable Integrity.
- ❖ You must possess biblical knowledge, skill in spiritual battle and wisdom for your proposed position. You must be a high quality Christian.

- ❖ You must demonstrate how you will aid in relieving Pastoral stress.
  - ❖ You must show how you will be of benefit to the unsaved community we are looking to service.
  - ❖ You must be able to prove your capacity to operate in your desired position. Spiritual maturity, divine revelation or an unction of the holy spirit are considered capacity qualifiers but must be scripturally based and biblically correct (*ex: selected scriptures must accurately and thoroughly support course content.*) Capacity will also include leadership qualities, teaching and communication skills.
  - ❖ You must be able to provide a complete and detailed outline of your plan or vision for your desired position.
  - ❖ You must agree to seek out and abide by the decisions of our judiciary committee when settling disputes within the Kingdom of God.
  - ❖ Your plan or vision statement should answer the following questions;
    - 1) What lasting effects will you have on the members of P.M.I. Church International?
    - 2) What are your guidelines for decision making?
    - 3) What are the guidelines you will be using for leadership selection?
    - 5) How will your method of operation be structured? If different than the structure provided.
    - 6) How will you market yourself to the unsaved community?
    - 7) How would you handle a dispute with someone in authority?

## *Legal Structure*

- 1.) Do you have a legally established ministry of your own?
- 2.) Are you ordained?
- 3.) Are you willing to adhere to the non-negotiable ordination requirements of P.O.W.W.E.R. Ministries Inc.?

- 4.) Are you willing to submit your ministry under the authority of P.O.W.W.E.R. Ministries Inc. and Bishop D.D. Gales as your overseer?
  - 5.) Will you actively and consistently pursue your vision and while assisting P.O.W.W.E.R. Ministries and fulfilling your duties in your assigned position?
  - 6.) Are you willing to pastor a PMI Church International at another location?

### Administrative capabilities
